RENTAL TERM

The rental term shall begin on the Effective Date and continue for twelve (12) consecutive months unless terminated in accordance with this Agreement.

The instrument remains the exclusive property of the Rental Company throughout the rental term.

PAYMENT TERMS

Number of Monthly Payments: 12

Payments shall continue for the full rental term regardless of usage unless otherwise agreed to in writing.

AUTHORIZATION FOR RECURRING PAYMENTS

Customer authorizes the Rental Company to automatically charge the payment method selected below for all monthly rental payments and authorized charges due under this Agreement.

Customer authorizes recurring monthly charges until this Agreement has been satisfied or terminated in writing.

Customer agrees to notify the Rental Company immediately of any changes to payment information.

Returned or rejected payments remain the responsibility of the Customer.

CUSTOMER RESPONSIBILITIES

Customer agrees to:

- Properly maintain the instrument.
- Keep the instrument in a secure location.
- Prevent exposure to excessive moisture, heat, or freezing temperatures.
- Notify the Rental Company immediately if the instrument becomes damaged or stolen.
- Not permit unauthorized repairs or modifications.

MAINTENANCE

Routine adjustments caused by normal wear may be covered by the Rental Company.

Repairs resulting from negligence or misuse shall be billed to the Customer.

Only technicians authorized by the Rental Company may perform repairs.

LOSS OR THEFT

The Customer shall notify the Rental Company within twenty-four (24) hours after discovering any loss or theft.

A police report may be required.

Customer remains financially responsible until the matter is resolved.

EARLY RETURN

Returning the instrument before expiration of the rental term does not automatically terminate payment obligations unless approved by the Rental Company in writing.

DEFAULT

Customer shall be in default if:

- Payments become more than thirty (30) days overdue.
- Customer abandons the instrument.
- Customer materially breaches this Agreement.

Upon default, the Rental Company may recover possession of the instrument and pursue any legal remedies available under Maryland law.

ELECTRONIC SIGNATURES

The parties agree that this Agreement may be executed electronically.

Electronic signatures, initials, and acknowledgments shall have the same force and legal effect as original handwritten signatures under the Maryland Uniform Electronic Transactions Act (Commercial Law Article, Title 21) and the federal Electronic Signatures in Global and National Commerce (E-SIGN) Act.

Electronic copies shall be deemed originals.

MARYLAND DISCLOSURES

This Agreement shall be governed by the laws of the State of Maryland.

The parties agree that:

1. Maryland courts shall have exclusive jurisdiction over disputes arising under this Agreement unless otherwise required by law.
2. Customer remains responsible for reasonable attorney's fees and court costs incurred in enforcing this Agreement where permitted by Maryland law.

3. Nothing contained herein waives any consumer rights provided under applicable Maryland law.
 4. Any unenforceable provision shall be severed without affecting the remainder of this Agreement.
 5. The Rental Company may report delinquent accounts to credit reporting agencies and collection agencies consistent with applicable federal and Maryland law.
 6. Customer agrees to promptly notify the Rental Company of any change in address, telephone number, or email address.
